February saw a high water event that affected parts of Gilchrist and highway 97. The Board is discussing the possibility of fixing the ditches behind homes on the eastside of town. Unfortunately a lot of the ditch that originally was put in for this reason has been filled in while some parts are on the State Forest, and the culverts south of the Theatre and along the school grounds need to be cleaned and a maintenance schedule established. This situation if not fixed could impact the town in a negative manner during a high rain event or rapid snow melt. The Board will keep you posted as this discussion continues.

The Architectural Review Committee (ARC) consists of Carol Kelley, Chair, Jody Herndon, Mary Dutcher, R.D. Buell, Lori Long and Board Liaison Doug Kelley. This last summer and fall were pretty quiet for the ARC, but the things that were submitted were all approved. Some of our friends and neighbors still think that it is necessary to just go ahead and start a project without approval from the ARC. Please believe that we always try to take care of those items that are sent to us in a timely fashion. It is in everyone's best interest to make sure and follow the rules so no one has to put up with a "Pink Elephant" right across the street from them. Board members Doug Kelley, Bill Perry, and ARC Chair Carol Kelley are developing new construction guidelines for the Association. There will be a draft submitted to the Board for suggestions and recommendations. It will be available for distribution when done.
