Your Board is trying to engage property owners within their HOA. No attendance, no voice.



Annual Dues:

Annual dues statements are coming. This is how our street lights, insurance, snow removal and road maintenance is paid for.

Architectural Review Committee (ARC).

As a reminder, any improvements or changes you plan on making to your property, require a review and signatures obtained through the Architectural Review Committee (ARC). Tree removal requires a separate form be filled out and submitted for review and signatures obtained <u>before</u> commencement of work to remove the tree(s).

Crescent Sanitary District (CSD)

CSD asks not to flush baby wipes or other wipes. These Do Not break down for years. They hang up and cause plugs in the lines and pumps.

On their website is a list and Do's and don't they ask you to read and follow.

During power outages limit your sewer system usage. Our Sewage System transfers Gilchrist Sewage by electrical pumps to the Crescent Treatment Plant. We have a small amount of sewer storage at each pumping station in Gilchrist. We do not want any overflow issues with our pumping stations.

As a Board we actively attend meetings and work with Crescent Sanitary District for the benefit of Gilchrist Homeowners.

As a reminder fire restrictions are in place. No debris or burn barrel use allowed. For further information contact Walker Range at 541-433-2451.
