## Annual Dues:

Annual dues statements have been distributed. Please if you haven't paid them, do so soon. This is how street lights, insurance, snow removal and road maintenance is paid for.

#### Annexation of Gilchrist into Crescent Sanitary District was signed and completed on April 27, 2022 by Klamath County Commissioners.

During power outages we ask you to limit your sewer system usage. Our Sewage System transfers Gilchrist Sewage by electrical pumps to the Crescent Treatment Plant. We have a small amount of sewer storage at each pumping station in Gilchrist. We do not want any overflow issues with our pumping stations.

As a Board we are actively working with Crescent Sanitary District to install backup generators at Gilchrist Lift Stations ASAP!
